- 1. Golf Canada Rules govern all play except where modified by local rules.
- 2. Ground under repair areas are designated by white post with green tops (GUR).
- 3. Flower beds are mandatory FREE Relief.
- 4. 150 yard markers are movable obstructions.
- 5. ALTERNATIVE TO STROKE AND DISTANCE FOR LOST BALL OR BALL OUT OF BOUNDS - The Model Local Rule (E5) is in effect for all regular and casual play. Refer to full procedure as recommended by Golf Canada posted in clubhouse.
- 6. Hitting Power line on hole #3: player MUST play another ball without penalty. Local Rule E11.
- 7. Swing and stance relief is allowed for ABNORMAL COURSE CONDITIONS that include IMMOVABLE OBSTRUCTIONS, GROUND UNDER REPAIR, ANIMAL HOLES, and TEMPORARY WATER.

Line of play to green is not necessarily allowed as part of this rule. Nearest point of COMPLETE relief not nearer to the hole plus one club length . Rule 16.1


